Booking Protocol

- You must contact our cellar door for bookings by phone, fax or email.
- You must confirm your booking within 48 hours of the date.

Booking times

- As our cellar door is small and busy it is important that you arrive just prior to your booking time. Your booking time will be held for 15 minutes only. Please call the Cellar Door if you are running late so that a later time *may be* allocated based on availability, but this cannot be guaranteed if we are busy.
- The latest time we can accept a booking above 10 pax is 3.30pm..
- The tour organiser is responsible for making bookings on behalf of guests, and for collecting the tasting fee
- **No BYO** alcohol is permitted.
- **No BBQs** or picnics are allowed
